POLICY FOR DETERMINATION OF MATERIALITY

This Policy is prepared in accordance with the requirements of the provisions of Regulation 30 (4) (ii) of the SEBI (Listing Obligation and Disclosure) Regulation, 2015 ("Listing Regulations"). The Board of Directors ("Board") of Decorous Investment And Trading Company Limited ("Company") has adopted this policy, for determination of materiality of events/information in order to enable the Company to broadly classify, categorize and promptly disclose to the stock exchanges material events/information, in accordance with the Regulations.

PURPOSE

- (b) the omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date;
- (c) In case where the criteria specified in sub-clauses (a) and (b) are not applicable, an event/ information may be treated as being material if in the opinion of the board of directors of listed entity, the event / information is considered material.
